Offering protection via a restricted serrated profile c/w side pin millings, Tigris® Tristar® provides a high level of security against illegal key copying and duplication. A security card provided with each cylinder lock ensures only the card holder has access to duplicate keys.

Manufactured and tested to meet UK and European product standards, Tigris® Tristar® achieves the maximum levels of product durability and attack resistance in accordance with the requirements of BSEN1303:2015 and BS3621:2012. Tested against the latest attack methods including bumping, snapping and freezing, Tigris® Tristar® has been successfully tested to the 2024 requirements of SS312 Diamond.

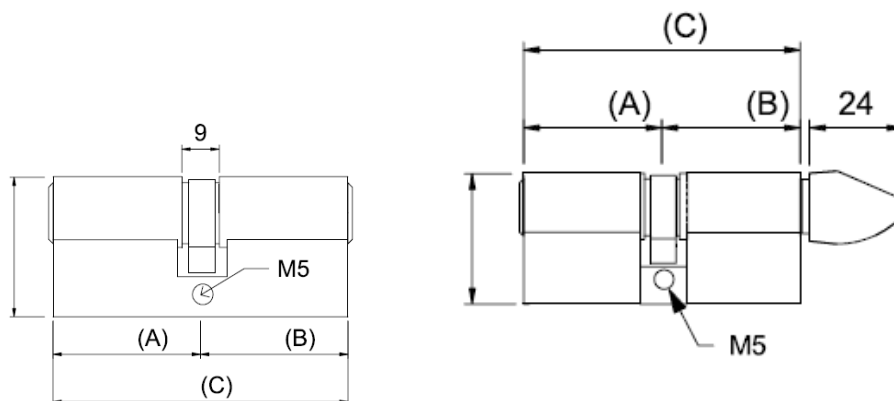
Tigris® Tristar® is available in both Standard Differ and Keyed Alike formats and has been independently tested to EN1634-1 achieving a 60 minute rating.
